4.	<u>USE OF SPACE:</u> Licensee may use the Space only (a) to market and sell the goods, (b) in compliance with Rules and Regulations made by the DSFM from time to time, (c) in compliance with all applicable statutes, ordinances, and regulations.	
5.	EXPENSES: Licensee shall furnish and do at its own expense any and all things permitted or required of Licensee in this Agreement.	
6.	<u>ALTERATIONS:</u> No alterations may be made to the Space or the Location by Licensee without the prior consent of the DSFM.	
7.	<u>RELEASE OF LIABILITY:</u> Licensee, on behalf of itself and its employees, volunteers, and agents, releases all rights of recovery against DSFM and its directors, officers, members, volunteers, and insurers from any claims, liability, and costs (including for personal injury or property damage) arising out of this Agreement with the License.	
8.	INDEMNIFICATION: Licensee agrees to indemnify, defend, and hold the DSFM harmless from any claim, liability, or cost (including attorney fees and legal expenses) arising out of or in connection with this Agreement or the License.
